**Nevada Coalition to End Domestic and Sexual Violence (NCEDSV)** is a statewide organization that was formed in 1980 to work toward the elimination of domestic and sexual violence against all persons and the empowerment of women, children and men.

NCEDSV helps Nevada's communities respond creatively and effectively to the needs of domestic and sexual violence survivors by advocating for change in our laws and systems; educating communities about the complex issues surrounding domestic and sexual violence and the potential solutions; and supporting the life-saving work of community-based advocacy organizations providing services.

What began as a handful of individuals, many strictly volunteer; has become a statewide community of policy makers, supporters, advocates and service providers.

NCEDSV is proud of a past filled with challenges and triumphs; confident in a present that offers opportunities and openings for real change; and excited about a future where violence is not a way of life for families in Nevada.

## What we do

### Advocate for Change

- Advocating on the state and federal level with other experts, Coalition members and service professionals for the needs of survivors.

### Educate Communities

- Offering training and knowledgeable consultation on domestic and sexual violence issues;
- Delivering experience-based technical assistance by skilled staff;
- Providing relevant, topical resources to victims and survivors and others working with them.

### Support Services

- Administering grant funding to support direct services.
- Providing access to other resources such as, language line translation services; long-term housing assistance to survivors and their families; and, L.I.F.E. Microloans to help survivors rebuild their credit history.
