## In Honor Of Domestic Violence Awareness Month Nevada Coalition to End Domestic and Sexual Violence Takes Action To Support Service Providers Through Training

Reno, Nev., (October 02, 2023) -- In their efforts to eliminate domestic violence in Nevada, a statewide organization, the <u>Nevada Coalition to End Domestic and Sexual</u> <u>Violence</u> (NCEDSV), joins coalitions across the nation to raise awareness for Domestic Violence Awareness Month on safety planning **throughout the month of October**.

Safety planning is a crucial step of advocacy, but what does it really mean? How does safety planning apply to survivors from different communities? The series of classes created by NCEDSV will give a general overview of safety planning, and have a follow-up series of training on how to safety plan for LGBTQIA+ survivors, survivors who use substances, Indigenous survivors, and how to safety plan around technology.

"For victim-survivors, safety planning is essential. Safety plans are the small and large things that victim-survivors map out in order to protect themselves, their children, and other close connections who may be in danger," said Elizabeth Abdur-Raheem, Executive Director of NCEDSV.

Safety plans may include the intricate details of what is needed to leave the home; safe words and codes with support individuals; plans for visiting familiar meeting places like schools and houses of worship; and workplace safety. Advocates can empower victim-survivors with tools and options to create flexible safety plans that are based on their unique situation.

"This safety planning campaign aims to highlight the ways developing a plan of action can reduce the risk of future harm by an abuser," said Abdur-Raheem. "Having a safety plan can save someone's life, making it a crucial part of an advocate's work with victim-survivors. Advocates develop safety plans in partnership with the victim-survivor. Safety plans center each victim-survivor's life expertise, and always honor their voice and choice."
